

TERMS AND CONDITIONS FOR BREATHWORK AFRICA

1. Detailed description of services

2. Indemnity

You agree to indemnify and hold harmless Breathwork Africa, its employees, associates, directors, affiliates and partners, for any and all losses, injuries, or damages resulting from any and all claims that arise from partaking in any Breathwork Africa activities such as workshops, forums, courses, breath classes and trainings.

3. Cancellation policy

We kindly request that you cancel at least fourteen (14) days before the scheduled start of the Event. This will allow us to offer your spot to another person. You may email us at info@breathworkafrica.co.za to cancel.

Cancellations made fourteen (14) days or more in advance of the Event date will receive a 100% refund. Cancellations made within fourteen (14) days will receive a 50% refund. Cancellations made within forty-eight (48) hours will not receive a refund.

4. Customer Privacy policy

Breathwork Africa shall take all reasonable steps to protect the personal information of users. For the purpose of this clause, "personal information" shall be defined as detailed in the Protection of Personal Information Act of 2020 (POPIA).

5. Payment options accepted

Payment may be made online via Visa or MasterCard, or by emailing us to arrange for alternative offline payment options.

6. Card acquiring and security

Card transactions will be acquired for Breathwork Africa via Peach Payments (Pty) Ltd who are the approved payment gateway for all South African Acquiring Banks. Peach Payments uses the strictest form of encryption, namely Secure Socket Layer 3 (SSL3) and no Card details are stored on the website.

7. Customer details separate from card details

Customer details will be stored by Breathwork Africa separately from card details which are entered by the client on Peach Payment's secure site. For more detail on Peach Payments refer to www.peachpayments.com.

8. Merchant outlet country and transaction currency

The merchant outlet country at the time of presenting payment options to the cardholder is South Africa. Transaction currency is South African Rand (ZAR). All transactions in currencies other than ZAR will be charged at the current exchange rate at the time of transaction.
